TLI40324 Certificate IV in Supply **Chain Operations**

This is a qualification for those engaged in supply chain operations and includes specialisations for logistics, purchasing and procurement, transport scheduling and warehousing.

KEY OUTCOMES

- Monitor the safety of transport activities, determining and monitoring chain of responsibility features in the Heavy Vehicle National Law (HVNL) and state/territory law and regulations.
- Monitor a supply chain operation, determining and monitoring supply chain functions; monitoring security of the supply chain; and contributing to forecasting in relation to warehousing, distribution and supply chain operations.
- Administer the implementation of fatigue management strategies, monitoring the implementation; recognising breaches of fatigue management policies, procedures and regulations; and developing and assessing staff competence in fatigue management.
- Apply and monitor security procedures in accordance with workplace and regulatory requirements within the transport and logistics industry.
- Assess and monitor optimum stock levels, assessing projected demand, assessing variables impacting on optimum stock levels, and determining and monitoring optimum inventory levels.
- Shift materials safely using manual handling methods, assessing the risks associated with relocating the load, planning the relocation process and carrying out the relocation in accordance with the plan.
- Implement improvements and monitor sustainable work practices, developing processes and tools, investigating current resource usage practices, setting target improvements, implementing improvements and monitoring performance.



- Implement and monitor environmental protection policies and procedures including accessing relevant information concerning environmental protection regulations and procedures as well as implementing and monitoring environmental hazard procedures, related control procedures and required records and documentation.
- Maintain stock control and receivals including establishing supply arrangements, monitoring and maintaining stock, processing receivals and storing stock, determining stock wastage and discrepancies and performing stock audits and reporting.
- Lead and facilitate work teams participating in work team planning, managing and developing work team performance, documenting and reviewing work team performance in accordance with relevant legislation and workplace procedures, and developing commitment and cooperation.
- Apply conflict and grievance resolution strategies, identifying potential conflict situations, developing and implementing appropriate conflict resolution strategies and using effective communication skills.
- Implement and coordinate accident and emergency procedures in accordance with relevant regulations and workplace procedures.
- Consolidate freight, combining or consolidating multiple shipments of products into higher volume shipments, and preparing related consignment documentation in accordance with relevant codes of practice and regulations.
- Manage personal work priorities and professional development, managing personal performance, setting and meeting personal work priorities, and developing and maintaining personal professional competence.
- Apply quality systems, working within a quality system; using quality systems, tools and techniques; and contributing to quality system continuous improvement processes.
